Please find below the updated Production and Transport Surcharge (**Surcharge**) rates for the upcoming fortnightly period.

As part of our commitment to transparency and market alignment, these rates are reviewed fortnightly based on the preceding two-week average of the National Terminal Gate Price (**NTGP**) for diesel, alongside the associated fluctuations in raw material and production costs.
